Because Tax Time, Series I Savings Bonds are accessible, convenient and easily given as gifts, tens of thousands of taxpayers have already found them to be a great way to start saving and building financial security.

"We are encouraging all taxpayers that receive refunds to devote as little as \$50 of their refund to buying a savings bond....we know that saving is extremely difficult for many working families, and these bonds enable people to invest for the long term, accumulate interest, and, if necessary, cash out and use that money for college education, retirement or other life-cycle events. They are a safe way to fulfill your financial dream and help secure the financial future of your loved ones. We encourage everyone to ask their tax preparer about savings bonds or use Form 8888 to purchase a bond this tax season," continued Ms. Hanley. This small investment can go a long way to help your children or grandchildren have a bright future. Simply ask your tax preparer how to save with Tax Time Series I Savings Bonds or make sure to use IRS Form 8888 to save in a bond.
