Event Info

The event is **FREE** and will feature information booths from City of Tempe departments and local nonprofits providing human services and programs to Tempe residents. In addition to info booths, there will be live entertainment and demonstrations, kid's fun zone, on-site services, food vendors, giveaways and more.

Last year, over 350 attended **Care Fair Tempe** and even more are expected this year as we join with the City of Tempe to celebrate **Tempe Human Services Day**. A series of speakers will be presenting information on topics surrounding social services.

Marketing of the event will take place through TCC and City of Tempe media outlets, schools, neighborhoods, business, posters, flyers, digital and social media, street banner at event site, and more.

Cost

For the right to be one of the only a few exclusive food vendors, there is a \$45 deposit required with the application. The deposit will be refunded/returned upon full participation or if not selected. Due to the purpose of the event, we ask that you keep your menu at family-friendly affordable pricing. Tempe Community Council approves all menu pricing and vendors.

Vendor Booth Specifics

- Each food vendor, if needed, will be provided with one 10 x 10 covered booth, including one 8' table, two chairs and small sign stating your organization's name.
- Set-up can begin as early as 6:30 am. All vendors are to be completely set-up no later than 8:30 am and remain completely operational through 12:00 pm/Noon.
- All vendor amenities and purchase opportunities must be disability/wheelchair accessible.
- Food trucks have the capacity to park under a parking shade structure and preferably self-contained (some electricity options are available upon request).
- All food vendor items are encouraged to utilize recyclable materials and/or be waste-reducing. Per City of Tempe's special events trash requirements, no styrofoam products are allowed. Recycle bins will be available and strongly encouraged for use by attendees. Trash receptacles are for use by event attendees only. Waste and water products from food production is to be removed from property and disposed of off-site.
- Applications do not guarantee a vendor spot. Space is limited. All vendor applications will be reviewed and selected based on providing a variety of food selections, pricing and space availability. All selected vendors will be notified by March 13.

- Tempe Community Council is not responsible for theft or damage of vendor's display or property. Vendors are responsible for their own space and agree to provide payment for any damage caused by unloading, loading and operations during Care Fair Tempe.
